OFF-LICENCE

Sections 29 and 114, Sale of Liquor Act 1989

DLA ref: OF/057/81/2010

PURSUANT to the Sale of Liquor Act 1989, Pyramid Valley Vineyards Limited is authorised to sell or deliver liquor on or from the premises situated at 548 Pyramid Valley Road, Hawarden, and known as "Pyramid Valley Vineyards", to any person for consumption off the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Part 6 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No liquor is to be sold or delivered on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day. However, a person may sell or deliver grape wine or fruit wine on Easter Sunday if the grape wine or fruit wine is made –
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated.
- (b) Liquor may be sold or delivered only on the following days and during the following hours:
Monday to Sunday 24 hours - Internet/Mail Order; EXCEPT THAT on the Thursday before Good Friday; and on Easter Saturday; and on Christmas Eve; and on the day before Anzac Day, liquor may only be sold between 7.00am and 12.00 midnight.
- (c) **Each of the following parts of the premises is an undesignated area: Service Area**
- (d) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs on the web site and ordering forms detailing the statutory restrictions on the supply of liquor to minors.

THE LICENSED PREMISES

In terms of Regulation 10 of the Sale of Liquor Regulations 1990, the sale or delivery of liquor is authorised from the premises generally. The premises, situated at 548 Pyramid Valley Road, Hawarden, are more precisely identified as outlined in a plan date stamped as received by the Hurunui District Licensing Agency on 9/09/10.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S


A copy of this licence must be displayed on the web site.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
